5. Treasurer's Report by Maggie Smith (MS)

- MS pointed out that in 2010-11 £5,000 was taken out of our reserves.
- 2011-12 we have managed to replenish 1/3 our reserves, therefore a distinct improvement.
- This was in the light of the fact that we only did 2 formal concerts and the Verdi didn't lose us very much money at all.
- We are not likely to have another year like this again.
- The Committee felt we should have 3 concerts and we will have 3 this year.
- We have to be careful with funds.
- We may have to dip into our reserves again but hopefully not too much looking at how many people we have here today.
- The next concert will be accompanied by a small ensemble. We need to be able to sing with a small accompaniment instead of a full orchestra as that is where all of the money was spent. The committee will be looking into this.
